

SOCIAL LITE VODKA 'GYM BAG' CONTEST (THE "CONTEST")  
OFFICIAL CONTEST RULES (THE "RULES")

**1. SPONSOR.** THE SPONSOR OF THIS CONTEST IS AWARE BEVERAGES INC (THE "CONTEST SPONSOR")
